If you have any additional changes to make to your manuscript, please send them to the copyeditor upon receiving the pre-proof queries (please do not send any changes to the editorial office). After the queries are returned, you'll receive page proofs, which must be returned rapidly. Please note that at the proof stage, we can only correct production errors or errors of scientific importance; other changes may delay publication.

To avoid any delays in communication, please let us know if you will be unavailable at any point in the next 4-6 weeks so that we can make alternative contact arrangements if necessary.

#### **Social Media**

We look forward to highlighting your paper on Twitter, unless you'd rather us not. If you or your co-authors are active on Twitter, please email me with a list of your personal handles, institutional handles, and any hashtags you'd like us to reference. If you'd prefer that we don't Tweet about your paper, please drop me an email to let me know. Thank you!

#### **Press Coverage**

Press coverage can be very helpful in disseminating your work to a wide audience. Although you'll hear directly from our press office, our general policy with regard to press coverage is that authors are welcome to talk with the popular press, talk with other scientific journals, and to press release information through their own universities, provided that this information is embargoed until 12:00pm NOON EST on the day of online publication. Since such information could, in principle, be used to speed publication of competing manuscripts, it is important to respect embargoes. The simplest way to achieve this is to refer enquiries from other journals directly to us. If your press office plans to press release your paper, you should instruct them to contact us before distributing the release. Please see the accompanying e-mail from the press office for details.

#### **Important note about bioRxiv**

If you've deposited a preprint on bioRxiv, you should see a link to your published paper on your bioRxiv preprint within a few weeks of it publishing online. If you don't, please contact the bioRxiv staff. Linking that preprint to your published paper is important because it allows others to cite your work accurately. Note bioRxiv's linking mechanism relies on a near-perfect match between the title of the preprint and the title of the paper, so if you've changed your title, you'll very likely need to contact them to ensure proper linking.

It's been a pleasure working with you. We welcome any feedback that you have and hope you've found our review process to be fair and constructive. We hope that you will consider us again in the future as a venue for your best work.
